1. The Bank of Tanzania has set aside funds for the Proposed construction of the Safe Custody Center at Dodoma Municipality. It is intended that part of the proceeds of the fund will be used to cover eligible payments under the contract for the Construction of the Safe Custody Center.
2. The Bank of Tanzania now invites bids from eligible contractors registered in Class One by the Contractors Registration Board. Bidding will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulation, 2005, GN 97

A complete set of Bidding Document and additional sets may be purchased by interested Bidders on the submission of a written application to the office of Secretary of Central Tender Board at the address given under paragraph 5 below and upon payment of a non-refundable fee of TZS 100,000.00 (Tanzanian Shillings One Hundred Only) in Banker's Cheque or Banker's Draft, payable to the Bank of Tanzania.
