1. This Invitation for Bids follows the General Procurement Notice for this Project which appeared in The Guardian, Daily News, The Express, Business Times and PPRA Journal from 7th to 14th November 2008
2. The **Bank of Tanzania** has set aside funds for its operations during the financial year 2008/09. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Supply of **Radio Communication and Security Equipments.**
3. The Bank of Tanzania now invites sealed bids from eligible Supplier of Radio Communication and Security Equipments. Interested bidders may bid for any lot, combination lots or all lots.

Bidding will be conducted through the International Competitive Tendering procedures specified in the Public Procurement (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 - Government Notice No. 97 and is open to all Bidders as defined in the Regulations.

A complete set of Bidding Document(s) in English and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS 100,000.00** or its equivalent in **USD**. Payment should either be by Banker's Draft, or Banker's Cheque, payable to Bank of Tanzania.
7. All bids must be accompanied by a Bid Security in the acceptable form as provided in the Bid Document in the amount of 2% of the total bid price.

All bids in one original plus two copies, properly filled in, and enclosed in plain envelopes clearly marked: **Tender number PA/082/2008-09/HQ/G/039 for Supply of Radio Communication and Security Equipments** indicating description and number of lot applied for and must be delivered to the address above before the **26th day of May 2009** at **12.30** hours local time. Bids will be opened promptly thereafter in public and in the presence of Bidders' or representatives who choose to attend in the opening at the Bank of Tanzania Board Room, 10 Mirambo Street, Dar es Salaam.
9. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
