1. This invitation for bids follows the general procurement notice for this project that appeared in UN Development Business (UNDB) issue number 692 of December 16, 2006.
2. The Government of the United Republic of Tanzania has secured funds from Development Partners towards the cost of the Financial Sector Support Project (FSP). It is intended that part of the proceeds of the funds be applied to eligible payments under the contract for supply of laptop computers and printers for the Directorate of Banking Supervision.
3. The Bank of Tanzania now invites sealed bids from eligible bidders for supply of the following:

4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
5. Interested eligible bidders may obtain further information from the office of **Secretary, Central Tender Board at Bank of Tanzania Head Office at 10 Mirambo Street, 13<sup>th</sup> Floor, North Tower from 8.30 am-4.30 pm on Monday to Friday except on public holidays..**

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **TZS 100,000.00**. Payment should either be by Electronic Payment transfer (Account Name: Tender Application Fee, Account Number.**9944712601** or Banker's Cheque, payable to **Bank of Tanzania**.

All bids in one original plus two copies, properly filled in, and enclosed in plain envelopes must be delivered to **THE SECRETARY, CENTRAL TENDER BOARD, BANK OF TANZANIA, P.O.BOX 2939, DAR ES SALAAM** at or before **11:00hours, Friday 26<sup>th</sup> February, 2010**. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening at the **Bank of Tanzania Conference Room , 17<sup>th</sup> Floor, North Tower, 10 Mirambo Street**.
8. All bids must be accompanied by a bid securing declaration in the format provided in the Bidding documents
9. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
