FOR THE PROPOSED REFURBISHMENT OF 10 MIRAMBO MIDDLE WING BUILDING AT BANK OF TANZANIA HEADQUARTERS –DAR-ES-SALAAM

1. The Bank of Tanzania has set aside funds for its operations during the financial year 2009/2010. It is intended that part of the fund will be used to cover the payment for refurbishment of its Middle Wing Building located at 10 Mirambo Headquarters – Dar es Salaam .
2. Following the completion of the extension to the BOT 10 Mirambo Headquarters project – Dar es Salaam which provides the state of the art building complex (i.e. South Tower, North Tower, North Block , Conference Center and Car Park) with built up modern facilities in terms of building fabric; mechanical, electrical and electronics systems complemented with security , Fire protection and suppression systems; it is therefore considered necessary to refurbish the old Middle Wing Building to match the other surrounding buildings under the mentioned project in nearly every aspect possible which subsequently the whole complex should work as one synchronized building complex.
3. The essence of synchronizing the building complex system is to manage and maintain the whole complex with shared infrastructure for Business Continuity and Security reasons.

Over and above the refurbishment of the Middle Wing Building should provide similar architectural aesthetic impact as that of the extension Building Complex project.

4. Bank of Tanzania now invites eligible consultants to express their interest in providing the required services. Interested consultants must provide information indicating their professional capability to undertake the consultancy. Such information may include brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.
5. A short list of consultants will be prepared on the basis of Expressions of Interest submitted to Bank of Tanzania in writing. The selection of consultants will be in accordance with the Public Procurement Act, 2004.
